- Tauna Groomsmith, CPS from Fremont County visiting today to observe SPC at work and also invite any interested Sublette coalition members to attend the Wyoming Prevention Action Alliance (WPAA) meeting in Lander, August 20. WPAA is a statewide prevention organization and forum for local coalitions to learn what other counties are doing in prevention. August 20 meeting is dedicated to working with Wyoming Association of Municipalities (WAM) to develop consistent prevention strategies (think ways to restrict youth access to vapes) across the state. Trisha cannot attend this meeting and it is important that Sublette have a presence to report Sublette concerns, if possible. Grant funding is available for coalition members to attend. Please contact Trisha if you are interested in attending.
- Clarification of Question, Persuade, Refer (QPR) training now available to all Sublette businesses, agencies, churches, schools, neighborhoods by Melinda Bobo. . QPR is a one hour training that instructs community members, regardless of training or background, how to "ask a question, save a life", if they are concerned that someone they know appears depressed, hopeless, and is contemplating suicide. QPR training now available to all Sublette businesses, agencies, churches, schools, neighborhoods from 12 Sublette trainers. Matthew Daniels and Aaron Preece presented schedule of September Sublette events for National and International Suicide Prevention Awareness Month.
- Opiates and Other Drugs Task Force report from Jen Zook: Task Force agreed to assess community and school interest and buy-in to a series of speakers spread out

over the school year to educate the community and lawmakers on the commercialization of marijuana in other states to learn more about what Wyoming will want to consider should decriminalization/legalization happen in Wyoming.
